- 3. Rate should be quoted for each article given in the attached schedule. No tenderer can quote more than one rate foe one item. One sample should be provided for each item (for Shoes & Chappal : 1 Pair). Adequate samples should be submitted in separate cover mentioning Item Number, Item Name, and Name of the tenderer to this office on or before 19/11/2024. No tenderer for the supply of articles marked "Current Market Rate" will be accepted. Rates should be exclusive of GST and inclusive of all other expenses and for delivery of the items at our factory at kuttanellur, Thrissur.
- 4. Quantity may be varied as per our requirement.
- 5. Each tenderer must remit an Earnest Money Deposit equal to 1% of total aggregate value offered through online.
- 6. Every tenderer should produce Address proof along with photo and signature to be attested by Gazetted Officer and Tax registration Certificate issued by the commercial tax department

attested by gazetted officer. They have to upload the clientele list as well. The proof of Annual turnover should be uploaded.
